## Implementation & Hosting Costs for:

- Cloud-based solution: GeniusDoc offers a Cloud-based solution that includes hosting and implementation fees for a monthly fee; cost is per provider.
- License-based solution: GeniusDoc offers a license-based solution for a one-time software license fee per provider with additional fees for implementation. Additionally, there is a supplemental monthly support & maintenance cost

On top of the implementation & possible hosting costs, this certified product-version could require additional costs for:

- A third-party partner that provides patient-specific education (170.314(a) (15) Patient-specific education resources). Costs are a monthly cost per provider.
